## **ALEXANDRA ROAD, N10** Planning applications up to Jul 2016

### **History**

The north-western corner where Clerkenwell meets with Tottenham and Friern Barnet was at the junction of Alexandra Road (which Friern Barnet's boundary followed) and Queen's Road, which was renamed Grosvenor Road. The OS Boundary Remark Book shows that there was a stone of St James Clerkenwell dated 1757 here with a Friern Barnet post dated 1851 and on either side Tottenham Posts dated 1859 and 1851 (*Malcolm Stokes in Hornsey Historical Society Bulletin 45 2004. Page 6*)

The cow sheds were at the corner of Alexandra Road and **Wetherill Road**, later the property was owned by Manuel Lloyd who used the old sheds for the storage of cardboard cartons. Pigs were kept on what is now the golf course (*Elizabeth Carter FB&DLHS 2 June 2001*)

Councillors voted last Tuesday to sell the freehold of the former sewage works in Pinkham Way to the North London Waste Authority. The site, close to the North Circular Road, was used as a sewage works during the 1960s, but has remained virtually unused ever since. The move follows several unsuccessful attempts by Barnet Council to find a use for the site, including a cash and carry store, a DIY superstore and housing. As part of the agreement with the NLWA, a 4.5- acre portion of the site will be retained by the authority as a possible new site for Barnet Council's current recycling depot at Bittacy Hill, Mill Hill, which deals with thousands of tons of dry recyclable waste collected each year. Council officials believe the Pinkham Way site is better placed because it is away from densely populated residential areas and close to major road links (*Barnet Press 20 Aug 2009. Page 10*)

## **ALL SAINTS' CHURCH (122 OAKLEIGH ROAD NORTH)**

This is Grade II listed by Historic England (formerly English Heritage)

### *DELL FIELD by John Heathfield*

All Saints Junior School just west of All Saints Church in Oakleigh Road North occupies what was formerly Dell Field. The field got its name from a dell or spinney that lay immediately north of what is today Queens Avenue. The field measured a tenth of a mile from north to south and 220 yards from east to west and the total area was 6.85 acres. The dell was 0.32 acres and in 1865 it contained four ponds. The next field, to the east, was Chapel Field of 8.62 acres and this is now covered by All Saints Church and by Loring Road. The field to the south of the school was Great Chapel Field of 10.72 acres. This ran south to Glebe Field and then to Friern Barnet Lane. The fields were all part of the manor of Friern Barnet and Whetstone, which was leased from 1731 to 1783 by William Strode, Stroude or Strowde. John Bacon leased the estate in 1783 and purchased it in 1800 and it was then occupied by his son, also named John. John senior borrowed money, using the estate as security but when he died on 26 February 1816, aged 78, he left a financial tangle. Manor Farm ran roughly from Friern Barnet Lane to Oakleigh Road and south as far as Bethune Park and it formed part of the estate which was purchased by John Miles in 1851 for £6,000 (*Friern Barnet Newsletter September 2010*)

Myddelton Park, a short cul-de-sac from Oakleigh Road opposite the entrance to Oakleigh Park South, was built by John Miles before 1882 when he erected All Saints' church and vicarage near by (*Victoria County History*)

When the church was built in 1882 they were asked to be the nucleus of the congregation; they had previously gone to St James and were asked to move to form the nucleus of the new congregation. The first vicar was there for 50 years and his father built the church for him. That was father Miles' father; he was in the publishing trade. Henry Miles, the first vicar, went into the ministry and his father paid for the church to be built. He was there from 1882 – 1932. The vicarage, I don't know whether that was built at the same time as the church or not, but that was a 13-bedroom house where **Cameron Close** now is. There were three floors and a little parish room up a flight of wooden stairs, a rambling old place with very large rooms. The Camerons followed on from Henry Miles so that was in 1932. They were there about 27 years and then Elmsley, then Adrian Benjamin. Only four vicars over a hundred years. After the initial repair, the church will apply for a grant. Rodell, the specialist works and access company, is refurbishing the Bath stone spire, which is around 100ft tall. Fr Gregory said: "It's a huge amount of money. And quite a lot is needed for the inside too. You don't want to be putting people in danger. One of the things we really pride ourselves in is keeping the church open, even during the week. I think if we left it much longer the potential for an accident would be great. I'm glad we have done everything we can." All Saints' Church was founded in 1882 by John Miles as a gift for his son, who became the church's first vicar. The majority of the church structure is original. Fr Platten said he will be relieved when the repairs are finished and the church doors can reopen (*Barnet Times 29 May 2014 page 7*)

All Saints' National school for infants first started out in 1859 on land in Whetstone given by John Miles, a Friern Barnet landowner and director of Methuen book publishers. A new school was built next to all Saints church in 1883 (*barnet.gov.uk/archives website*)

## **ALMA PRIMARY SCHOOL, FRIERN BARNET LANE**

Spring 2016. Next September will see the opening of a new primary school on the site of the former Whetstone Police Station. The Alma Primary School is currently in Moss Hall Grove, North Finchley and the new site in Whetstone will accommodate 120 pupils. It will nearly double in numbers over the next five years with an annual intake of about 30 pupils up to a maximum of 210. It is mainly a Jewish school but accepts children of other faiths. Planning permission has now been granted. And the structure of the old building will be mainly retained, except that the former cell block will be demolished and a new school hall together with a kitchen and servery will be built in its place. The existing front entrance is being removed and pedestrian access will be at the rear where a security officer will be housed. There will be a new delivery area along the front of the building with access to the bin area. Deliveries will be restricted to between 9am and 2pm. There has been extensive consultation on travel arrangements to and from school. It is unlikely that young children will cycle to school, although there will be a few bays at the rear for staff cycles. Whilst the opening of a new school is welcomed, the majority of children will come by car which is causing some local concern. There is already a busy junction in the rush hour and due to width of Friern Barnet Lane at this point there is insufficient space for stopping outside where the current parking restrictions are 7am to 7pm. The school is aware of these issues and has therefore devised a scheme whereby parents will drive into the school playground (the former police yard) through the existing entrance (which will be wide enough for two vehicles) to drop off or pick up their children, perform a loop and drive out again. There will be allocated time slots at collection times and the security officer will supervise the speedy arrival and departure of cars. Barnet Council have no plans to install traffic lights at the junction with the High Road. There will be no on-site parking for cars. As far as we are aware, parents will be encouraged to turn left out of the school entrance rather than attempt to join the queuing traffic at the junction. It is anticipated that about 60 cars will arrive at the school between 7.30 and 9am. Once it is fully staffed up to 12 members of staff will need to park in neighbouring streets which are already close to capacity. This should be seen in the light of the extra traffic and need for parking in view of about 1000 new homes being built or planned between the old Furnitureland site and Northway House. This is in addition to the redevelopment of Sweets Way. There will be activities for the entire community from a café and shop to day and some night activities for people with dementia, holistic therapies and a synagogue. The cost of developing the new home is £10 million. The cost of upgrading the current facilities at Asher Loftus Way and creating the campus is £5.6 million. Over £13.75 million of this has already been donated from the community. Jewish Care is currently fundraising to secure the remainder of the funding required. The entire cost of this project will be funded thanks to the generosity of supporters across the community. Residents of the 30-year old Ella and Ridley Jacobs House were informed in October that should they wish, they will be offered a place at one of the three care homes at Asher Loftus Way. Sam Beckman Day Centre users will be offered an increased range of services and activities when the centre is relocated to Friern Barnet.

**Layout**

There are 76 residential properties, 31 on the south side and 45 on the north side. 26 houses are detached, 38 semi-detached, 10 terraced and there are 2 flats

**History**

In 1889, only 10 houses stood in Athenaeum Road, which was lined with sports grounds (*Victoria County History page 13*)

From 1899 there was a private lawn tennis club in Athenaeum Road (*Victoria County History page 24*)

A meeting-room in Athenaeum Road between 1889 and 1897 had disappeared by 1900 and a Gospel hall there in 1925 was disused by 1930 (*Victoria County History page 33*)

Christian Brethren from Highgate began to worship in Athenaeum Road, Whetstone c.1884. They met in a converted house with a capacity of c. 25, probably the Christians' meeting room recorded between 1889 and 1925, until in 1926 they moved to a new brick hall in Oakleigh Road North, which seated 100. Oakleigh hall was enlarged in 1954, renamed Oakleigh chapel shortly afterwards, and still used in 1975 (*Victoria County History page 33*)

The road was renumbered in 1932 (*Kelly's Directory of Finchley & Friern Barnet*)

The Athenaeum Institute (which gave its own name to the road) opened in 1881 with a grand concert. It had a hall seating 400 people, a billiard room, library and reading room. For the more active, tennis and croquet lawns were laid out. Although initially successful, the project soon collapsed and by 1892 the buildings were being used for industrial purposes. (*Article in Barnet Times 2 August 2001, by Percy Reboul and John Heathfield*)

His memory also stretches to a line of cobble stones, the boundary between Finchley and Friern Barnet. A similar line appeared in Athenaeum Road and Chandos Avenue (*Barnet Borough Times Thursday 21 August 1986. Page 2*)

Athenaeum Road was originally called East Lane because it ran eastwards from the corner of Whetstone Town to East Barnet Parish church. The Ordnance Survey map of 1864 shows a barn, a gravel pit and four cottages. The cottages belonged to W Matthews, dairyman and publican who also owned the Green Man and several nearby fields. Matthews was born in 1830 and by 1871 some of his relatives were living in two of the cottages. Sam Matthews, who was an agricultural labourer, had one of the cottages and George Matthews, a dairyman, had another. The other two cottages were occupied by farm labourers and a police constable. In 1797 the land nearby was owned by W Tash who sold his estate to Sir Simon Haughton-Clarks who lived in Oakhill House and whose funeral monument is prominent in East Barnet churchyard. In 1869 the land was sold to the Whetstone Freehold Estate Company, who built 25 houses on what was to become the Oakleigh Park Estate. They were large detached houses with 5 to 9 principal bedrooms, 3 or 4 reception rooms and carriage sweeps. Each house was to cost not less than £1,000, but they were not all sold and as late as 1936 some were being let to rent. The agents appear to have always lived on the estate. In 1871 Richard Looker, Secretary to the Land Company, lived at The Hollies. In 1886 the Secretary was A Waldron who lived originally at the foot of Athenaeum Road, and later at Springfield at

the south west corner of Oakleigh Park North and Athenaeum Road. W B Passmore lived for a time at Carlstone in Oakleigh Park North. He succeeded Joseph Baxendale as occupant of Woodside House and, after the death of his wife, he moved to a smaller house in Oakleigh Park. There is a monument to his wife in St John's Church. Baxendale had been the last surviving trustee of the old Whetstone and Highgate Turnpike Trust and, after his death, Passmore took over his papers which have unfortunately since been lost.

The cast iron marker on the south side of Athenaeum Road marked CHG marks the boundary between the Colney Hatch Gas Company's mains which supplied the estate and the Barnet Gas Company whose main runs along Whetstone High Road as far as North Finchley and Totteridge. The Barnet Press of 12 Nov 1884 advertises the sale of "seven copyhold cottages having considerable frontage to the High Road and return frontage to Athenaeum Road, brick and timber built and let to respectable tenants at a total annual rent of £72." These were subsequently demolished about 1895 and replaced by the bank and a row of shops. About 1897 the buildings of the former Athenaeum Club was taken over by Birt Acres, who set up a photographic works there. Acres were an American inventor whom played a prominent part in the development of moving pictures which used a strip of celluloid which was coated with a light sensitive chemical. Apparently the celluloid base and the coating expanded at a different rate when exposed to the heat of the projector which led to the flaking of the film. Acres invented a way of dealing with this. He later set up in partnership with British Xylonite but the business was short-lived and closed after a few years.

**History**

In the north half of the parish only the eastern section from the Avenue to Russell Lane, dominated by council estates, is like the Freehold. Although parts remain waste, the Avenue has been rebuilt and the terraces in East and Oakleigh roads are being cleared (*Victoria County History 15*)

At the northern end of New Southgate (the name replaced Betstile) the streets around The Avenue were described as one of the roughest north London suburbs in 1891. (*Godfrey Old Ordnance Survey Map Friern Barnet & New Southgate 1898*)

The nearby Avenue district was cleared after 1969; by 1975, when there were still vacant patches, the Avenue itself, Stewards Holte Walk, Coppies Grove, and flats called Holmesdale and Stanhope had been built. (*Victoria County History page 14*)

4 Oct 1965. ...Friern Barnet (The Avenue) Compulsory Purchase Order 1963 (*Barnet Council Minutes 4 Oct 1965*)

The following article in the 21 August 1953 issue of *Muswell Hill Record* vividly recalls the event: "Behind green shutters at The Avenue, Friern Barnet, where once horses stamped and fretted, where the ring of hammer on anvil sounded, where clouds of pungent smoke poured from the horses' hooves and red sparks spluttered on cold steel, is now a vast armada of machinery. The old chimney remains, banked up with coal, as in days gone by, iron rings for the bridles are still fixed in the walls, but the place itself is now a springsmith's workshop. Above the old forge live two white-haired sisters – Miss Eleanor Bray and Miss Annie Elizabeth Bray, whose father took over the business in July, 1882, when the younger of the two sisters was seven months old. For a time, William Edwin Bray was the manager of the forge, and then he became the owner. When he died, horses were still coming to be shod from as far away as Finchley, Palmers Green and Wood Green, and the business was taken over by his eldest son, and in later years by his second son, but with the years there was less trade and less iron to make the shoes. Two years ago the last of the brothers died, but the two sisters still live where they always lived – above the green-shuttered forge. Soon it may be theirs no longer. They already rent the forge and may make negotiations for the sale."
