## **EAST CRESCENT, N11** Planning applications up to Sep 2014

### **History**

6 Feb 1946. The Council recommended that the Council assign the name East Crescent to the private street constructed for users of temporary houses on the above mentioned site (*Friern Barnet Council Minutes 6 Feb 1946*)

### **Infrastructure**

11 Jan 2005. Alongside the pavement on the northern side, alongside the railway line, a sturdy new metal fence (silvery mesh) has been installed (*John Donovan FB&DLHS*)

27 Jun 1966. East Crescent Housing Area Phase VI. 5- storey block of 30 flats and maisonettes and workshop for Housing Department and 64 garages and parking spaces. Provision of £260,000 made (*Barnet Council Minutes*)

Redundant Car Park Site East Crescent Estate. 25 Oct 2000 & 14 Mar 2001. Planning application for demolition of existing 2 storey car park, access ramp and block of brick sheds and erection of 3 storey block with rooms in roof, of 6 flats (1 4-bed and 5 2-bed) and attached block of 3 storey houses with associated car parking and landscaping.
