History

Finchley UDC bought part of the Woodhouse Estate for housing 1n 1915, building some houses immediately and a second wave from 1919. This picture shows Ingleway nearing completion in June 1921 (*Finchley & Friern Barnet* by Stewart Gillies and Pamela Taylor. Plate no 172)

The Ingleway estate during development in 1921. After the First World War there was a Parliamentary Order requiring local authorities to build good affordable houses for rent. The new houses were then called council houses. The fields had previously been part of the grounds of the Woodhouse estate (*Around Whetstone & North Finchley* by John Heathfield, page 150)
