No ? (1 Cleveland Villas). 1889. Alfred Leonard Price, Sapper, 1st/3rd Field Company, Royal Engineers, died 21 March 1916 aged 27, buried in Friern Barnet. Alfred was born in 1889 in Friern Barnet, sixth of the seven children (two boys and five girls) of Alfred and Jane Price. He was baptised, together with his youngest sister Francis 11 October 1891 in St James's. At the time of his birth the family was living at 1 Cleveland Villas. They later moved to 66 Holly Park Road and then to 18 Beaconsfield Road. Alfred followed his father and older brother William into the building trade. His father died in 1909, aged 57. The Friern Barnet parish magazine of May 1916 reported "the death of Sapper Alfred Price of 13 Beaconsfield Road. He was on his way to the Front for the first time, but was taken ill of pneumonia at Portsmouth and succumbed. His funeral took place on 25 March at Friern Barnet (*Parish of Friern Barnet Graves and Memorials of the First World War. Page 19*)

No 4. 1914. Athol Mildern, Gunner, Royal Field artillery, killed in action 13 August 1918, aged 28, buried in Thiennes British cemetery, France, which contains burials arising from the German offensive in the area from May 1918. Joseph Stratton Mildern, Rifleman, 9th Battalion, King's Royal Rifle Corps, died of wounds 9 August 1917, aged 31, buried in Longuenesse (St Omer) cemetery – a hospital centre. Joseph and Athol were the third and fifth of the seven children (three girls, four boys) of Edward, a carpenter, and Alice Mildern. Both were born in St Marylebone, Joseph in 1885, Athol in 1891. By 1911 the family had moved to Willesden Green. Athol was employed as a salesman. Joseph was an assistant at a draper's shop in Hackney, living there with the draper and his family and the other four assistants. By the time of the war the Mildern family had moved to Friern Barnet and were living at 4 Parkhurst Road. Athol was married 22 August 1917 (by then in the army) in St Paul's Haringay, to Lilian Wingfield (*Parish of Friern Barnet Graves and Memorials of the First World War. Page 19*)

Ronald Henry List, Lance-corporal, 5th (City of London) Battalion, London Regiment (London Rifle Brigade), killed in action 1 July 1916, aged 24, commemorated on the Thiepval Memorail, the Somme. He had been in France since 14 March 1915. Ronald was born in 1892, son of Robert and Lydia List. He was baptised 18 October 1891 in St Peter's Holborn. He had an older and younger sister. All three children were born in Holborn. By 1911 the family had moved to 8 Parkhurst Road. Ronald, like his father, worked as a draper's assistant. Friern Barnet parish magazine August 1916: "the death of Robert List. He had just come in after rescuing a wounded comrade when he was shot. As a Grammar school boy, as a member of the Catechism and as a server at the altar, he had always identified himself closely with the church." (*Parish of Friern Barnet Graves and Memorials of the First World War. Page 18*)

No 17. 1903. Harold Frank Turner, Rifleman, 20th Battalion, King's Royal Rifle Corps, died of wounds 26 May 1917, aged 23, buried in Etaples Military cemetery, Pas de Calais, centre of a concentration of military hospitals. He had been serving in

France since 18 May 1915. Sidney Ronald Turner, Private, 11<sup>th</sup> Battalion, Essex Regiment, killed in action 22 April 1917, commemorated on the Loos Memorial, Pas de Calais. Sidney and Harold were the fourth and fifth of six children (five boys and one girl) of William, a carpenter, and Florence Turner. Sidney was born in 1892 in Croydon, Harold in 1894 after the family had moved to Friern Barnet. Harold was baptised 1 July 1894 in St James's Church. The family was then living in Glenthorne Road; they later moved to 41 Bellevue Road. Their father, William, died in 1903 aged 51. The eldest child, also William, died in 1910, aged 25. By 1911 the family had moved again to 17 Parkhurst Road and, by the time of the war, were living at 13 Macdonald Road. Before the war Sidney was working as a railway clerk, Harold as a clerk. The Friern Barnet parish magazine of July 1917 expresses "deepest sympathy for Mrs Turner in the loss of her son Harold, who died of wounds on 26 May after lingering for months in great suffering. Mrs Turner's anxiety is further increased by the report that Sidney is wounded and missing. He was last seen in an advance in some wire entanglements. Frank, her youngest son has also been wounded and is now in hospital in England." Harold and Sidney are commemorated in the inscription on the grave of their father and brother (*Parish of Friern Barnet Graves and Memorials of the First World War. Page 23*)

Nos 25-29. 11 Sep 1973. Planning application for rebuilding children's home (*Barnet Council*)

No 25 (Parkhurst Road Children's Home). 1986. 25 Parkhurst Road is a purpose built children's home situated in a pleasant residential area, close to transport and shops. It is a multi-purpose, long stay group home, and caters for 11 children aged between 6 years and 17 years of age. There are 6 bedrooms – 2 single rooms semi-independent, 3 rooms each for 2 children and 1 room for 3 children. Each child has their own wardrobe, chest of drawers, and in some cases, an under-bed drawer. The ground floor is open plan with a Games room, Dining Room and TV Room. The house is run on a "Sharing Basis" with both children and staff taking part in decisions. Children are expected to respect other people's privacy and property (*extract from '25 Parkhurst Road Children's Home'. Barnet Social Services 1986*)

No 26. 1903. Lawrence Henry Hewlett, Private, 61st Battalion, Machine Gun Corps, killed in action 24 March 1918 aged 19, commemorated on the Pozieres Memorial near Albert. The memorial bears the names of those lost in the period of crises March to April 1918, when the 5th Army was driven back across the Somme battlefields. Lawrence was born in 1898 in Wood Green, eldest child of Henry, railway clerk, and Annie Hewlett. He had a sister and brother. In 1901 the family was living in Slough, but by 1903, when his sister was born, they were living in Friern Barnet at 26 Parkhurst Road. She was baptised in St James's They were still there in 1907 when his brother was born, but, by 1911 had moved to 159 Maitstone Road, New Southgate (*Parish of Friern Barnet Graves and Memorials of the First World War. Page 16*)

No 26. 9 Dec 1944. Weekly rent is quoted as £1 3s 3d (*Friern Barnet UDC Minutes*)

No 26. 14 Nov 1946. Application for requisition to be lifted (*Friern Barnet UDC Minutes*)

No 26. 8 Jan 1968. Planning application for conversion into two self-contained flats (*Barnet Council N01547*)

No 28. 18 Sep 1987 & 23 Feb 1998. Planning application for conversion of house into 4 flats, single storey, 2 storey and 3 storey rear extensions and alterations to roof with dormer window on front elevation. Provision of 3 car parking spaces (*Barnet Council N/08813*)

No 30. 14 Apr 1959. Application approved for converting bedroom into bathroom (*Friern Barnet UDC Minutes*)

No 32. My grandfather, E H Mould, lived for many years at 32 Parkhurst Road. He was an accountant and a tea broker in the City. I presume he chose the location because it was within easy walking distance of New Southgate railway station, and hence the City. He died in 1950 and is buried in the churchyard of St James the Great, Friern Barnet Lane, and so is his daughter Eva Mason, who died in 1928 in childbirth (*A E Mould, Friern Barnet Newsletter No 35*)

No 32. 5 Jul 1912. Application approved for cycle shed (Mr H Wall) (*Friern Barnet UDC Minutes*)

No 33. 1896. Oliver C Wall, Lance-corporal, 12th Battalion, Tank Corps, died 23 October 1918, aged 22, buried Etaples Military Cemetery, Pas de Calais, centre of a concentration of military hospitals. Oliver was born in Friern Barnet in 1896, third of nine children of Henry, gas and water engineer, and Minnie Wall. He had five sisters and three brothers. The family lived at 33 Parkhurst Road (*Parish of Friern Barnet Graves and Memorials of the First World War. Page 23*)

No 33 (33 Parkhurst Road Children's Home). 1986. 33 Parkhurst Road is a Children's Home for up to 12 boys and girls aged from 5 to 17 years. It is situated in a pleasant road in New Southgate and is fairly close to another home at number 25 Parkhurst Road, as well as shops, bus routes and a tube station. There are 2 single rooms and 3 shared rooms so it is likely that you will have to share a room with 1, 2 or 3 others, but you will have your own wardrobe and drawers for putting your clothes in. There is also a cupboard under each bed for putting toys and other personal possessions in. There aren't any rules as such since we try to make it a home and not an institution (*extract from 33 Parkhurst Road Children's Home. Barnet Social Services 1986*)

William was born in 1896 in Wood Green, youngest of the four children of Alfred, a draughtsman, and Mary Wilkinson. He had three sisters, of whom the youngest, Marguerite, died aged three in 1897. By 1901 the family had moved to Florence Villa, Stanford Road. They later moved to 60 Parkhurst Road. Friern Barnet parish magazine for December 1917 reported "Willie Wilkinson is missing. He was last seen going 'over the top; after which neither he or his company have since been heard of.'" The magazine of February 1918 reports his death as confirmed (*Parish of Friern Barnet Graves and Memorials of the First World War. Page 24*)

HOUSE NUMBERS by *David Berguer*

When researching the history of an area old maps and street directories are a valuable source of information. However, one of the problems facing historians is the renumbering of streets, which became necessary as an area developed and new buildings were erected on what had formerly been vacant land. For example, in the 1937 *Kelly's Directory of Finchley and Friern Barnet* the building in High Road Whetstone, on the corner of Chandos Avenue, was numbered 14 Chandos Parade but by 1939 it had been renumbered 1370 High Road. In fact the whole of the High Road had been renumbered, so it was a one-off solution to the problem. A more recent case was highlighted by Karl Ruge who sent us a copy of a letter he had received from Barnet Council in August 1966. This referred to the demolition of two large houses in **Friern Barnet Lane** between Park Way and **The Ridgeway**. The Borough Engineer and Surveyor explained the problem: "The numbering of new dwellings following the re-development of a site comprising more units than those which previously existed, does present some problems, particularly if re-numbering of other properties in the street is to be avoided. You may rest assured, however, that such a course is only adopted as a last resort, the usual method being to allocate a name to the new development, i.e. ".....Court" or ".....House", and to number the dwellings from No 1 onwards accordingly. This action, of course, cannot be taken until work has started, since it often occurs that there is more than one approval attached to a site involving varying numbers of units." As it turned out, a simpler solution was found. Twenty houses were eventually built on the site and the houses were numbered thus: Park Way south side (from Friern Barnet Lane) numbers 2H, 2G, 2E, 2D, 2C, 2B, 2A, Friern Barnet Lane (from north) 77A, 77, 75A, 75, 73A, 73, 71A, 71 The Ridgeway north side (from Friern Barnet Lane) 1E, 1D, 1C, 1B, 1A. ### **History**

...the road there called Pembroke Road (formerly Milton Avenue). *(Extract from Indenture for 1 Pembroke Road dated 27 Aug 1914)*

An institute in the Freehold and a youth club active in 1887 may have been precursors of the Freehold social institute in Pembroke Road which existed in Pembroke Road by 1912 - 13. *(Victoria County History page 24)*

Baptists from 1865 probably attended New Southgate Baptist church, sometimes described as in Colney Hatch. Before 1887 it founded a mission hall at Pembroke road, known as the Pembroke Baptist mission room in 1902 and renamed the United mission hall c.1922 when joined by seceders from the Freehold mission in Sydney Road. Although still governed by a trust deed held by the mother church, the congregation managed its own affairs in 1975. The original timber-framed and corrugated iron hut was then used for Sunday school and other activities but wooden huts of c.1918 at the rear had been replaced c.1968 by a brick building, containing a church for 75-100. *(Victoria County History page 33)*

The City Display Organisation (CDO) used Alexandra Palace for war work, and later for commercial purposes. This was a very interesting company in its own right, whose founder, Fred Keil, was born in the Prague area of Czechoslovakia, just before the end of the First World War. He went to Berlin, after studying in Prague, and chose to study commercial art and Art as Propaganda, because this was a subject that was not taught in the other European countries. He then came to Britain and married a Welsh girl in 1937. His training proved very useful to his new country, and the company he had set up was used in Britain's fight against Germany. His original factory was in Pembroke Road, Muswell Hill, where his workers made three-dimensional advertising aids. Then in 1941 Alexandra Palace was requisitioned for him, by the Ministry of Food, as it offered a big enough space for the production of public information and government propaganda material, which was then urgently required.... *(Hornsey Historical Society Bulletin 43 Page 28)*

## **PERT CLOSE, N10** Planning applications Dec 2016

### **History**

Slum clearance in the area was proposed as long ago as 1933, but new flats were not built in Hampden Road until 1975 and Pert Close, a large estate of 3-storey flats was erected c1970. The name of the nearby Freehold Community Centre is the only link with the early days of the development. Hollickwood Park is built on the former council refuse tip. Fed-up Residents' Paint Attack on Illegal Billboard. By Janine Kelso. An illegal billboard was defaced by residents using paint bombs and water guns in a desperate bid to get rid of it. Residents in Pert Close, Muswell Hill, were angry that the advertising billboard – which faced the North Circular – had not been removed by Barnet Council. The billboard, which advertised hair products, has since been removed. Ms Hutchinson said “he billboard was ugly and it blocked our view. We were so annoyed about it being put up that we defaced it so that it defeats its purpose. We love defacing it. It was like being a child again. The paintbombs exploded all over us and we had to use paint-rollers on sticks to get the paint on, as the poster is so massive.” In 2001, a billboard was put up illegally in the same place. It took residents a year of campaigning before it was removed by Barnet Council. And residents were furious that another one was put up that was much bigger than before. Ms Hitchinson added: “The billboard was mammoth and we didn't want to wait for another year before it was removed. More people should take action rather than being apathetic.” A spokesman for Barnet Council said: “Advertisements of size 3.1m by 6.2m and larger require ‘express advertising consent’. The council has no record of consent being sought in this instance. If a hoarding is felt to be illegally placed, the council has two routes to remove it: prosecution through the Magistrate's court or seeking an injunction from a High Court judge requesting the power to remove it.” Footnote by David Berguer: The billboard in question was a vertical one, rather than the normal horizontal (landscape) size, consequently the back of it could be seen looming over the fence separating the North Circular and Pert Close. 19 Aug 2010. A firm of property developers has agreed to shell out £4 million towards community facilities after it flouted planning laws. Comer Homes Group, which

developed the Princess Park Manor in Royal drive, Friern Barnet, into luxury flats had been granted planning permission in January 2004 to build 64 flats and offices in the east wing of the site. But instead the group built 83 flats and made unauthorised alterations to the outside of the former mental hospital. In June 2009 Barnet Council served the group with enforcement notices which it appealed against. A public inquiry into the case was held over several days in May and June but, during adjournments, the council and the developer came to a mutual agreement. Last week the planning inspector granted permission for 82 of the flats – one has been deemed not fit for residential purposes – to stay, subject to the group making some alterations to keep it in line with the building's grade II listing. In addition, the firm will pay the council's legal costs. The group will also make contributions to the council, of which £3.4 million will go towards the building of affordable homes in the area and almost £250,000 will go towards education provisions. Cabinet member for housing Richard Cornelius said: "This was a difficult and unprecedented case, involving a huge amount of hard work by the council, which will see a significant benefit to the community. I am delighted we stood firm and have finally reached a resolution which benefits the borough and the flat owners themselves who were in a difficult position living in properties without planning permission." Luke Comer from Comer Homes Group told The Press the issue had occurred after an "oversight" by the group's architects. He said: "We decided smaller flats would be better to sell and submitted planning permission, which was never dealt with properly. We tried to put the mistake right as soon as we knew about it. We advised residents not to sell at this time, but if they had to, we would buy the flat and cover their costs – but nobody did sell." (*Barnet Press Aug 19 2010. Page 2*)
