

## **QUEENS AVENUE, N20** Planning applications Aug 2017

### **Layout**

There are 56 residential units. 8 houses are detached, 35 semi-detached and 13 terraced

### **History**

Myddelton Park, a short cul-de-sac from Oakleigh Road opposite the entrance to Oakleigh Park South, was built by John Miles before 1882 when he erected **All Saints'** church and vicarage near by. In 1903 the whole of his estate between Friern Barnet Lane and Oakleigh Road was acquired by the National Land Corporation which planned freehold houses for prosperous commuters and extended Myddelton Park to Friern Barnet Lane along an existing path, Loring and Pollard Roads, and Queens Avenue. ## **QUEENSWELL SCHOOL** Planning applications up to Oct 2015

### **History**

Queenswell School was built in 1950 (*John Heathfield, FB&DLHS*)

After 1951, when Queenswell School was opened, the building (*St James School*) was used as a nursery school (*Finchley & Whetstone Past by John Heathfield, page 70*)

26 Jun 1967. The Borough Estates Officer reported that as instructed in Jan 1966 he had negotiated for the acquisition of approx 1.6 acres of land between Oakleigh Road North and Friern Barnet Lane immediately to the north of Queenswell School. The land was required to enlarge Queenswell School to accommodate children from the married quarters which the Ministry of Defence intended to erect on their adjacent land. The purchase price had been agreed at £46,080. The sub-Committee were informed that the western boundary of the Queenswell School site encroached slightly on to land which was owned by the Ministry of Defence who had agreed to convey this portion of land to the Council free of charge (*Barnet Council Minutes*)

5 Feb 1969. The Borough Architect reported that he had prepared a scheme in conjunction with the Chief Education Officer and the Borough Planning Officer, estimated cost £12,000, for converting premises at Queenswell Primary School (formerly occupied by the Barnet Sea Cadet Corps) to provide additional accommodation. In view of the urgent need to provide the accommodation to meet the increased roll at the school, tenders had been invited from eight firms, the lowest was from G M Tomkins Ltd for the sum of £11,567 1s 3d. The Borough Architect was instructed this tender (*Barnet Council Minutes*)
